RULES FOR VENDORS

All items to be sold must be **APPROVED**, legal and in good taste as determined by “The Voice” Juneteenth Committee. Any vendor found selling or providing items that were not approved to sell or provide may be removed from the event immediately.

ALCOHOL...NO EXCEPTIONS****

Exhibitors are responsible for protection of their own displays, goods and materials. “The Voice” will not be responsible for any loss or damage to exhibitor’s property.

Your booth and personnel must be clean and orderly at all times.

Booths must be staffed at all times.

You are responsible for clean up of your booth space during and after the festival.

All vendors must remain open for business during festival operating hours.

Amplified music may not be broadcast from any booth.

All food vendors must obtain a temporary food service permit from the Williamson County & Cities Health District. Forms are available at www.wcchd.org. There is a \$50 fee for the permit.

- All booth sizes are 10x10 or 10x20. Please make sure that you purchase the proper size as you will be required to stay entirely within your assigned space.
